Agape Pamoja is a non-profit organization that shows actionable love and intentional community to others. Agape is the Greek word for "love". Pamoja is the Swahili word for "community" or "doing things together". The purpose for Agape Pamoja is to help serve the multi-faceted needs of refugees from war-torn countries, residing in Kansas City by providing housing assistance, educational support, food, clothing, community, involvement, leadership development, and other aid while intentionally doing life together.

Part III, line 4a Program Accomplishments

In 2019, Agape Pamjoa acquired 8 new Blessing Houses and had 7 new disenfranchised families from the refugee community move into these renovated houses. This brought the total number of houses to 10 and the families supported directly through this program to 9. These families saw the square footage of their house more than double and their rent costs were reduced by 50% or more which equated to \$600+ per month per family savings. Agape Pamoja also started a youth outreach program that focused on assisting the youth of the African refugee community in leaderships skills, educational support and life skills. This was accomplished by a weekly Sunday morning children's program for elementary age kids and a monthly student leader program for middle and high school kids.
