Born To Be Great II offers the aforementioned services to students who are at-risk of academic failure, or who are socio and economically disadvantaged, or who have been diagnosed with a disability (intellectual, cognitive, physical,) etc. This program requires that we purchase various items like: Training material, curriculum, workbooks, school supplies, assessments, clothing, snacks, etc. We also purchased assistive technology to support our students' accommodations that are outlined in their Individual Education Plans

To monitor program effectiveness participants are pre-assessed to determine their academic level of achievement. We provide on-going monitoring of student progress by administering benchmark assessments at the conclusion of each learning objective taught and we also administer a post-assessment at the conclusion of tutoring. The gain between the pre and the post assessment determines program quality and effectiveness
