**REFUGEE SUPPORT SERVICES:** resettled 677 refugees from Somalia, Ethiopia, Eritrea, Democratic Republic of Congo, Uganda, Tanzania, Sudan, Burma, Ukraine, Moldova, Uzbekistan, Russia, Mongolia, Armenia, Belarus, Afghanistan, Bhutan, Iran, Iraq, Syria, Yemen, Palestine, Nepal. We provided initial cultural orientation and case management to 100% of all refugee adults. We provided linkage of 100% of newly arrived refugees to public assistance and available social services.

**EMPLOYMENT SERVICES:** provided employment services to 357 refugees.

**FINANCIAL LITERACY:** provided financial literacy training to 294 refugees.

**WOMEN EMPOWERMENT Economic Integration Services:** provided services to 75 refugee women.

**HEALTH ACCESS:** provided assistance with linkage to healthcare screening and follow up medical services to 1,122 refugees; helped navigate healthcare system, access primary physicians, establish medical home, and address both chronic and acute medical conditions; removed barriers to accessing healthcare system, including but not limited to, transportation, language, and cultural barriers; assured that refugees are comfortable and self-sufficient in management health issues for themselves and their children; provided medical case management to 125 most vulnerable refugees and 160 survivors of torture; and provided 2,364 information/referral and linkage services to refugees & asylees. We also provided coordination of services to 160 survivors of torture.

**SCHOOL PLACEMENT:** provided school placement to 100% of all school age refugee children that arrived during FY 2017 as well as providing Parent-School Liaison services to 70 refugee parents.

**CASE MANAGEMENT FOR SENIORS:** provided case management, socialization services and linkages to services to 282 refugee seniors.

**MENTORSHIP:** 260 refugee children benefited from mentorship services.

**IMMIGRATION SERVICES:** enrolled 192 Legal Permanent Residents (LPRs) in to Citizenship/Integration classes; provided 250 LPRs with citizenship eligibility screenings; assisted 164 individuals with citizenship applications; and provided immigration services to 367 individuals.

**INTERPRETER SERVICES:** provided trained interpreters for 15,592 appointments in medical, mental health, educational, social services, and human services setting, assuring the provision of linguistically and culturally sensitive services to Limited English Proficiency population of Central Ohio. We also provided pro bono interpreter services for 60 appointments.
