TWENTY-FOUR HOUR SUPERVISION AND NURTURANCE, COUPLED WITH DAILY ROUTINES AND STRUCTURE, ARE VIEWED AS NECESSARY COMPONENTS TO PROMOTE SELF-ESTEEM, SECURITY, AND INTERNAL CONTROLS.
