OUR MISSION TO HELP PEOPLE ACHIEVE INDEPENDENCE IS EXPRESSED THROUGHOUT THE ORGANIZATION. Approximately 75% OF THOSE EMPLOYED IN OUR STORES, ECOMMERCE, TRANSPORTATION AND WAREHOUSE OPERATIONS HAVE MULTIPLE BARRIERS TO EMPLOYMENT. In 2019, Discover Goodwill provided meaningful and gainful employment to over 215 individuals with developmental and economic challenges through its self-sustaining business enterprises comprised of laundry, janitorial, document management and fleet maintenance services. Discover Goodwill's customers included military bases, government facilities, hospitality organizations, health care agencies, educational institutions and private businesses.

In 2019, Discover Goodwill's Career Development Center provided job training and support services for nearly 11,000 un- or under-employed individuals throughout the community. These services included job preparation courses, work experience programs and professional certification courses directed at making career-challenged individuals' job-ready. IN PARTNERSHIP WITH EL PASO COUNTY DEPARTMENT OF HUMAN SERVICES, DISCOVER GOODWILL ALSO PLACED OVER 4,700 JOB SEEKERS INTO EMPLOYMENT WITH NET ANNUAL EARNINGS OF \$71.7 MILLION AND OVERALL ECONOMIC IMPACT TOTALING \$437.5 MILLION.
