BRI (Brothers Redevelopment Inc) expanded the service area for our HMR to include the second largest population county in Colorado, El Paso County. Overall, the program completed in-home modifications and improvements for 143 income qualified senior and disabled homeowners, thereby helping them achieve mobility, prevent injury, and age-in-place safely and comfortably. The PAINT-A-THON program celebrated 38 seasons, with 2,260 volunteers painting 118 senior and disabled homeowners across the Colorado front range - all free to the homeowner. Collectively, the program saved homeowners \$515,100 in home maintenance costs and enabled the recipients to redirect their resources to important household expenses including groceries, medications, and health care costs.
