**The primary exempt purpose of the Colorado Council on Economic Education is to provide education programs and services for Colorado K-12 teachers and the community to assist in improving economic education and personal financial literacy for students in Colorado K-12 schools.**

**CCEE also makes available to K-12 teachers and school districts a wide range of grade-appropriate economics and personal financial literacy (PFL) curriculum resources.**

**During this fiscal year, CCEE delivered 51 economics and PFL teacher training courses. More than 1,000 teachers and student teachers attended CCEE's professional development programs. We estimate that these teachers will reach about 115,000 students each year of their teaching career with an improved ability to teach economics and PFL in their K-12 classrooms. The total number of instructional hours delivered by CCEE's contract Ph.D. economics professors and mentor teachers was 11,890.**

**CCEE also provides a stock market portfolio simulation program, called the Stock Market Experience (SME). The SME program is provided to teachers of Colorado students in grades 3-12. It is a comprehensive, engaging, real-world, online investment simulation that fosters an understanding of the personal financial literacy (PFL) concepts of smart investing and saving, among others. Student stock market simulation programs have been proven to improve student learning in PFL, economics, math and language arts. CCEE operates three SME sessions each school year.**

**This year, 470 teachers made CCEE's Stock Market Experience available to more than 27,000 students statewide.**
