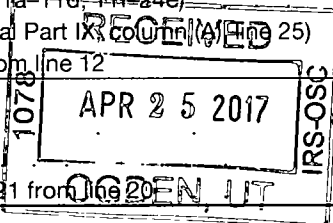

The Authority believes that income tax filing positions will be sustained upon examination and does not anticipate any adjustments that would result in a material adverse affect on the Authority's financial condition, results of operations or cash flows. Accordingly, the Authority has not recorded any reserves, or related accruals for interest and penalties for uncertain income tax positions at December 31, 2016.

The Authority is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Authority believes it is no longer subject to income tax examinations for years prior to 2013.
