Salaries for each position are reviewed every 2-3 years using data from the Colorado Non-Profit Association salary survey, comparisons with similar salaries at Federally Qualified Health Centers, and private sector salaries. Dentists employed by Dental Aid receive a base salary, and are eligible for a production bonus if their production reaches a certain level. All other employees are eligible for a merit increase that falls within the parameters adopted with the budget. Generally, each employee may receive a performance evaluation yearly at the time of his or her anniversary of employment. The CEO is evaluated annually by the Board of Directors acting as a committee of the whole. Any compensation changes are approved at the same level as those approved for other Dental Aid staff in the budget. The result of the evaluation is conveyed by the Board Chair to the CEO either in writing or via email, and the Director of Finance is copied with any salary change information.
