SYSTEMS AND PUBLIC POLICY ADVOCACY CCADV EDUCATES POLICY LEADERS, AND ADVOCATES FOR LOCAL, STATE, AND FEDERAL POLICIES WITH THE POTENTIAL TO END DOMESTIC VIOLENCE, WHILE ENHANCING INTERVENTIONS, RIGHTS, AND OPTIONS FOR SURVIVORS AND ACCOUNTABILITY FOR THOSE WHO CAUSE HARM DURING THE TIME IT WILL TAKE TO REALIZE OUR VISION. THE COALITION ADVOCATES FOR SURVIVORS AND COMMUNITY-BASED DOMESTIC VIOLENCE AND SIMILAR NONPROFIT ORGANIZATIONS IN LEGISLATIVE AND OTHER SYSTEMS, AND WITH OTHER DECISION-MAKERS, FUNDERS AND THE MEDIA WORKING WITH SURVIVORS AND MEDICAL PROFESSIONALS IN 2017, CCADV HELPED TO PASS HB17-1322, INCREASING SURVIVOR SAFETY AND AUTONOMY BY RE-ESTABLISHING CHOICES THROUGH COLLABORATIVE DECISION-MAKING WITH THEIR HEALTHCARE PROVIDERS ABOUT WHETHER TO REPORT DOMESTIC VIOLENCE INCIDENTS TO LAW ENFORCEMENT.
