AFTER DISCUSSION AND BOARD APPROVAL, THE BOARD AUTHORIZES SIGNING AND FILING THE FORM 990 WITH THE IRS.

FORM 990, PART VI, LINE 12C - EXPLANATION OF MONITORING AND ENFORCEMENT OF CONFLICTS

THE EXECUTIVE DIRECTOR REVIEWS THE ANNUAL CONFLICT OF INTEREST DECLARATIONS. IN ADDITION, THERE IS A PERMANENT ITEM ON THE BOARD OF DIRECTORS MEETING AGENDAS REMINDING MEMBERS TO UPDATE THEIR CONFLICT OF INTEREST DECLARATIONS, AS NEEDED.

FORM 990, PART VI, LINE 15A - COMPENSATION REVIEW & APPROVAL PROCESS - CEO & TOP MANAGEMENT

THE EXECUTIVE COMMITTEE GOES INTO EXECUTIVE SESSION TO REVIEW AND DETERMINE COMPENSATION FOR THE EXECUTIVE DIRECTOR, SO NO MINUTES ARE KEPT. HOWEVER, THE COMPENSATION IS INCLUDED IN THE PERSONNEL BUDGET THAT IS REVIEWED BY THE FINANCE COMMITTEE AND THE BOARD OF DIRECTORS AND RECORDED IN THE MINUTES. THE EXECUTIVE DIRECTOR RECOMMENDS COMPENSATION FOR ALL OTHER EMPLOYEES, WHICH IS REVIEWED BY THE EXECUTIVE COMMITTEE AS A PART OF THE BUDGETARY PROCESS. THE ENTIRE BUDGET IS THEN REVIEWED BY THE FINANCE COMMITTEE AND BOARD OF DIRECTORS AND RECORDED IN THE MINUTES.
