The Organization has adopted ASC 740, Accounting for Uncertainty in Income Taxes. The standard prescribes a minimum recognition threshold and measurement methodology that a tax position taken or expected to be taken in a tax return required to meet before being recognized in the financial statements. It also provides guidance for de-recognition, classification, interest and penalties, accounting in interim periods, disclosure, and transition. The Organization is under regular audit by the tax authorities. The Organization believes that it has appropriate support for the positions taken on its information returns and that its annual tax provision includes amount sufficient to pay any assessments. Nonetheless, the amounts ultimately paid, if any, upon resolution of the issues raised by the taxing authorities may differ materially from the amounts accrued for each year. The Organization files information returns in the United States federal jurisdiction. The Organization is no longer subject to examinations for United States federal information returns before 2013. Management believes the tax-exempt status of the organization would be upheld upon examination. The Organization classifies any interest on underpayments of any tax and classifies penalties in connection with underpayments of tax as "Other Expense."</p>
