Family Support Services (FSS) - Family Advocates partner with families to set SMART goals, address immediate crisis situations with concrete supports, work on financial literacy, obtain parenting education, access resources, follow up on referrals, and provide interpretation services. Between July 1, 2019 and June 30, 2020 the Family Center provided family support services to 117 families. Expected and measured results from participants include improved family functioning, enhanced protective factors for children in the household, and access to concrete supports to reduce immediate crisis situations. Strengthening Community Response to COVID-19 through Parent Leader Network. LPFCC successfully engaged its Parent Leader Network to support coordination of food distribution, concrete resources and outreach during the outbreak in March 2020. It was truly incredible to observe the speedy organization, distribution of duties and coordination among LPFCCs staff members, other organizations and the Parent Leaders, to meet heightened community need. The target population is residents of five mobile home parks/neighborhoods containing 115 families in La Plata County. Colorado Community Response Program (CCR) - is offered in Archuleta, La Plata, and San Juan counties to deliver brief intervention services and support to families and children that have been screened-out for child abuse and neglect stemming from referrals to the Department of Human Services. 50 families were served last year and 50 are anticipated to be served this fiscal year. Results include improved family functioning in at least one of the measured domains of the Colorado Family Support Assessment (CFSA 2.0), increased protective factors for children and no further involvement with Child Protective Services upon program completion.

Form 990, Part III, Line 4b:

The Bayfield Family Center's Afterschool and Summer Enrichment Program offers low-cost after school and summer childcare with a primary focus on exercise, healthy nutrition, and education. (\$160 less than financials due to in-kind rent and services not included in 990).

Form 990, Part III, Line 4c:

The Early Childhood Education and Parenting Program - We offer three Early Childhood Education programs including Parents as Teachers, Circle of Parents in Recovery, parenting groups with classes such as Love and Logic, Nurturing Parents and other educational sessions as requested by parents. The target population are parents or caregivers who have children under 18. Last fiscal year 99 parents benefited from these programs. LPFCC PAT Affiliate has met and exceeded essential requirements according to the 2019-2020 Affiliate Performance Report. In October 2020, LPFCC PAT program was awarded the Blue Ribbon by the Parents as Teachers National Office. Receiving this endorsement means our program is one of the top ones in the Nation.
