In 2020, Manna provided 96,679 meals, and freely distributed 138,824 pounds of food to partnering organizations and individuals/families experiencing food insecurity, and also distributed 9,416 bags of weekend meals to students in need. The supportive services team offers outreach, housing assistance and case management, and provides resources directly to clients such as bus tokens/passes, clothing, hair cut vouchers, thrift store vouchers, prescription coverage, emergency food boxes, hygiene supplies, referrals, assistance in obtaining identification documents (birth certificates, IDs, and drivers licenses), and assistance filing applications for VI-SPDAT (housing) and SNAP (food stamps).

GARDEN PROGRAM - Manna's Garden provides fresh produce for the preparation of our nutritious meals and to distribute to food insecure individuals/families. The program educates individuals about basic nutrition and horticulture in order to empower them to take ownership of their diet and health. During 2020, the Manna Garden produced 2,114 pounds of vegetables and ran a low income, SNAP, CSA (Community Supported Agriculture) Shares Program for 50 households. In 2020, our school garden program taught horticulture to 130 students in local schools ranging from kindergarten thru fifth grade.

CULINARY TRAINING PROGRAM - Mannas Culinary Program teaches job skills, life/employability skills and food service industry knowledge to La Plata County's most at-risk population to help people overcome their barriers to achieve gainful employment. Our goal is for every student to graduate with the needed culinary and life skills to capture gainful employment. In 2020, Manna's Culinary Program was able to adapt to COVID-19 regulations and facilitate three, in-person sessions of classes, graduating 8 students.
