THE BOULDER SHELTER FOR THE HOMELESS PROVIDES SHELTER, MEALS AND SUPPORTIVE SERVICES FOR HOMELESS ADULTS. THE SHELTER SERVED 103,364 MEALS AND PROVIDED 44,358 BEDS FOR 1,582 INDIVIDUALS DURING THE YEAR. THE SHELTER'S TRANSITION PROGRAM PROVIDED 2,100 CASE MANAGEMENT CONTACTS AND GRADUATED 39 RESIDENTS. 55 FORMERLY CHRONICALLY HOMELESS INDIVIDUALS RESIDED IN PERMANENT SUPPORTIVE HOUSING THROUGH THE HOUSING FIRST PROGRAM. THE TRANSITIONAL HOUSING PROGRAM SERVED 15 ADULT CLIENTS AND THEIR FAMILIES. APPROXIMATELY 3,300 CONTACTS WERE MADE WITH HOMELESS PEOPLE BY BOULDER COUNTY CARES VOLUNTEERS.
