For each conflict of interest disclosed to the Chairman of the Board of Directors, the Chairman will determine whether to (a) Take no action, (b) Assume full disclosure to the Board of Directors and other individuals covered by this policy, (c) Ask the person to recuse from participation in related discussions or decisions within SWCI, or (d) Ask the person to resign, become subject to possible removal in accordance with SWCIs removal procedures.
