MHCD uses the following process in setting officer compensation. The MHCD board retained the firm of Longnecker and Associates to complete a CEO salary comparability study. This is completed approximately every three years. Longnecker and Associates uses a number of surveys, comparing salaries based on the size of the organization, healthcare, mental health, non-profit, region, and other factors. The board has a CEO compensation subcommittee which is comprised of the personnel committee and executive committee members who consider the data reported from Longnecker and Associates as well as MSEC data and other sources of information in determining the CEO's salary and incentive compensation. The process was last undertaken in 2017. A similar process is undertaken for the other officers and key employees of the organization. Similarly, the MHCD board retained the services of the firm of Longnecker and Associates to prepare a salary comparability study for these other individuals. The board then has oversight and communication with the CEO over the executive team compensation packages, reviews performance metrics within the compensation package quarterly, and authorized the CEO to operate within the parameters of the agreed upon compensation structure. This process was last performed in 2017 for the executive team.</p>
