The Center provides organized activities and services to senior citizens in the Castle Rock area and surrounding cities. We currently have 1,120 members. We also provide transportation services for seniors and adults with disabilities in Douglas County. 198 individuals utilized the transportation program during 2019. We publish a monthly newsletter and also maintain a website and Facebook page. We provide seniors friendship, peer support, wellness and nutrition programs, activities, sports and entertainment. The Center is also a Volunteers of America (VOA) congregate meals site 3 times a week and provides VOA Meals on Wheels delivery service for Douglas County. Our volunteers provided the Center with 27,890 hours of service during 2019.
