Juvenile Diversion & Restorative Justice Program Diversion Program Youth are referred to the LPYS Diversion Program by the courts, law enforcement, and the school resource officers in lieu of having criminal charges filed against them for felony, misdemeanor, and petty offenses The program is designed to provide youth with resources, support, and direction that will ultimately decrease their chances of reentering the criminal justice system Youth are referred for offenses such as marijuana and alcohol possession, theft/shoplifting, vandalism, and assault such as a fight In fy18, 87 youth referred by law enforcement and the courts were served 85% of these youth completed the program successfully, and their charges were not filed in juvenile court Additionally, La Plata Youth Services provides services to area youth as a strengths based alternative to truancy court In addition to providing truant youth with assessment and case management services, La Plata Youth Services houses the La Plata County Collaborative Regional Management Program, or LPCRCMP, and has worked collaboratively to develop a model of care to address the specific needs of truant and at-risk children and youth The LPCRCMP Coordinator is an employee of La Plata Youth Services In fy18, 8 youth referred for truancy were served 30% of these youth improved their attendance Restorative Justice LPYS coordinates with a number of community conferencing specialists who provide mediation to victims of juvenile crime in our community In fy18, LPYS began offering ReThinking Substances (RTS), a restorative intervention for youth, and their supportive adults, involved in first-time, petty level marijuana and/or alcohol offenses LPYS also works with school district personnel in the county to support school-based restorative practices and programs School-based restorative justice builds a stronger school community through providing kids with deeper connections and a sense of belonging among their peers, teachers, and families Additionally, these practices provide schools with an alternative method to traditional discipline where suspension and expulsion would more commonly be used In fy18, LPYS focused school-based RJ efforts in 10 schools in 2 school districts, further growing a culture for restorative interventions and a supportive school climate In fy18, a total of 286 youth engaged in these restorative programs 27 youth, 30 supportive adults, and 7 community members participated in RTS, 7 youth and 4 victims participated in community and/or victim-offender conferences, and 252 students participated in school-based restorative programs

La Plata County Regional Collaborative Management Program LPYS serves as the lead agency for a series of client-centered, community-based, collaborative programs, designed to serve the highest-need youth in our community LPCRCMP and LPYS partnership programs include (a) the School Multidisciplinary Review Team, or SMART, (b) the Community-in-Schools Partnership Program (CISP), and (c) Radical Possibilities Mentorship Program SMART The Student Multidisciplinary Assessment Review Team, or SMART, is a community-based case management tool, which addresses the needs of habitually truant and at-risk students facing complex need situations that require wraparound care and collaborative case management In fy18, 17 youth participated in SMART review meetings Community-in-Schools Partnership (CISP) Program provides a wrap-around, early intervention and prevention response to the issues facing chronically absent, habitually truant, and at-risk students and their families Programming concentrates on improving school climate and coordinated delivery of community resources in the school setting, including mentorship, family outreach, mental health, case management, restorative justice, tutoring, and transportation In fy18, CISP reached 289 youth 107 were provided with in-school therapy in 6 schools, 40 youth participated in suicide prevention workshops, and 142 students participated in substance abuse prevention workshops Radical Possibilities Mentorship (RP) RP provides support to youth who experience significant adversity and provides robust training and professional development to burgeoning practitioners in mental health fields In fy18, RP served 10 youth Of these youth, 50% experienced an increase in attendance from previous year, 33% a reduction in school-based behavioral incidents from previous year, 100% of the youth in the program did not commit an offense while participating in the program, 80% of the youth reported improvements in happiness and friendships, and 60% of the youth reported improvements in family relationships
