

1. The credit card processing company that is used on the foundation's website charges a percentage fee on all credit card donations.

In 2017 donations by credit card were made through the foundation's website in the amount of \$6,385. Of this amount, the credit card processing company took a fee of \$190.57 and the foundation actually received \$6,194.43.

2. The Foundation's check no. 1148, in the amount of \$225.00 and sent to the service provider on behalf of a child on September 28, 2016, was never presented for payment. In 2017 the Foundation received an email from the patient's social worker stating that the contemplated medical appointment had never been arranged. Therefore, the Foundation's end-of-year net assets amount, reported on the Foundation's 2016 990-EZ tax return, was \$225.00 higher than it should have been.
