THE CENTER PROVIDES COMMUNITY-BASED PROGRAMS THAT PROMOTE ECONOMIC AND SOCIAL INTEGRATION AND ADDRESS A RANGE OF ISSUES INCLUDING NAVIGATING INSTITUTIONAL OBSTACLES. THE CENTER SERVES MORE THAN 1,500 LOW-INCOME FAMILIES PER YEAR. MOST OF THE FAMILIES SERVED ARE COMPRISED OF NON-NATIVE-ENGLISH-SPEAKING PARENTS STRUGGLING TO LEARN ENGLISH WHILE WORKING TO SUPPORT THEIR FAMILIES AND TO PREPARE THEIR CHILDREN TO SUCCEED IN SCHOOL. THROUGH EDUCATION, THE CENTER WORKS TO HELP THESE FAMILIES BECOME SELF-SUFFICIENT, CONTRIBUTING MEMBERS OF THE DENVER COMMUNITY.
