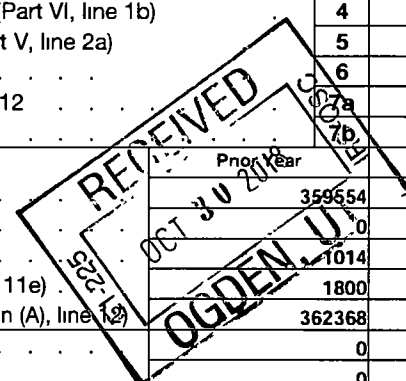

Rebuilding Days Our flagship program brings together hundreds of volunteers and dozens of corporate sponsors to repair, revitalize and rehabilitate homes and community centers; at no cost to the residents or users of the center. In 2017 Rebuilding Together Metro Denver rehabilitated 5 homes, 5 community centers and hosted 3 neighborhood safety events. Through these 13 projects we impacted nearly 1,350 lives.

General Repairs, Safety Upgrades and Emergency Repairs: Another no cost program providing homeowners who are older adults, living with a disability or veterans with critical home repairs and modifications. In 2017 Rebuilding Together Metro Denver provided services to 41 residents in 22 homes. Services included replacing water heaters and furnaces, installing grab bars, energy upgrades, replacing appliances, plumbing repairs, and other essentials.
