 During it's 17 years of operations, Community Development Institute Head Start (CDI HS) has operated 215 programs under the National Interim Management Contract funded by Office of Head Start (OHS), providing Head Start (HS) and Early Head Start (EHS) services to low-income children and families. Head Start programs under CDI HS's interim management receive administration and oversight of the day-to-day HS and/or EHS services in communities where a HS/EHS grantee has relinquished, is under suspension, or has had its grant terminated by OHS. To date, CDI HS has served funded enrollment of 112,868 children.
