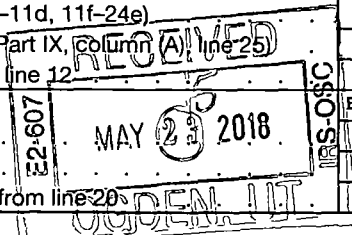

These 19 families along with others residing in the four properties participated in parent support groups, parenting classes, and connections to community resources to support their children's education. One hundred (100%) of three- and four-year-olds were enrolled in preschool.

The Boulder Housing Partners Foundation received funding from the Piton Foundation of Gary Community Investments and the Littlefield Foundation to implement Bringing School Home Early Childhood program at eight highly affordable housing sites. This program is focused on helping parents prepare their children for kindergarten by supporting the emotional, social, physical, and intellectual development of young children. Parents benefit from parenting classes, play groups, play groups, social support networks in their communities, preschool enrollment, and entrance into evidence-based in-home visitation programs for young children.

The Boulder Housing Partners Foundation entered into a new Grant Agreement with Boulder Housing Partners on 10/1/17. This agreement supports the implementation of the Bringing School Home program with Foundation funds from the Piton Foundation and Gary Community Investments and the Littlefield Foundation. The Foundation granted BHP \$388,559, payable over two years, if awarded in Year 2, to support staff and leadership to execute the Bringing School Home Early Childhood program by expanding the program to additional families, empowering parents to nurture their children's healthy development, increasing parents' participation in mutual support networks, and supporting parents to enroll their children in preschool or daycare.
