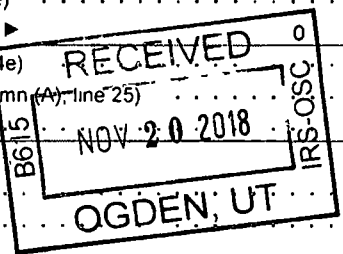

Ocean Bay Community Development Corporation's management team have provided referrals to over 3,000 (elderly people with disabilities, youth, young adult and adults, to supportive services and other community resources. The SC's assess service needs of residents and link them to appropriate providers and community resources. They also facilitate programs and services such as health and wellness, job training or transportation. A resource directory of local social service agencies and providers, assisted residents with applications for benefits and entitlement programs. These referrals help seniors maintain their independence and remain in their apartments, low income families can achieve greater economic security by linking them with programs to improve their literacy, job skills, education and management training.

Office of Children and Family Services (OCFS) transportation approximately 3,000 seniors and disabled residents are provided on a yearly basis transportation and 15% of those riders are youth with disabilities. Presently our transportation provided to seniors and the disabled living in the Rockaways is offered to various places such as grocery stores, post-office, doctor appointments, food pantries, civic, tenant and block association meeting, senior day care centers etc. OBCDC and other service providers also offer workshops to seniors and youth around quality of life issues where they can address these issues collectively and individually. OBCDC offered a number of intergenerational cultural and recreational trips have been sponsored by OBCDC
