Department of Housing and Urban Development (HUD) OBCDC's Service Coordinators (SC) have coordinated a local program coordinating committee with local service providers to ensure the 3,500 plus participants living in public housing are linked to supportive services needed to achieve self-sufficiency. The SC's act as liaison between the public housing residents and local service providers. SC's provide general case management which includes intake, assessment, education and referral of residents to service providers in the local community. SC's also promote and encourage residents to build informal support networks with other residents, family and friends.

4b (Code) (Expenses \$ 88,565 including grants of \$) (Revenue \$)

Office of Children and Family Services (OCFS) OBCDC provides transportation to an estimated 3,000-3,500 per year to seniors and disabled residents living in various places on the Rockaway Peninsula. Our van service provides access to grocery stores, post office, doctor offices, food pantries, civic events, tenant and block association meetings, senior day care centers OBCDC staff promotes transportation services by posting flyers at all high traffic areas such as housing developments, grocery stores, churches, laundry mats etc. OBCDC staff also provides life workshops for seniors and youth that focus on quality of life issues, health and wellness, workforce and other issues that can be addressed individually. We have also coordinated cultural and recreational intergenerational trips that have been provided by OBCDC and other CBO's.

New York Community Trust (NYCT) 700 residents who have been unemployed and underemployed with limited education and professional training were provided professional training with soft and hard skills training so they can enter new employment opportunities with options for mobility and financial independence. OBCDC staff provided work readiness training to prepare unemployed and underemployed Rockaway residents for employment, connecting program participants with professional certification and/or education programs in multiple sectors that will enhance their marketability to employers provided job placement assistance to everyone who enrolls in our workforce services program and we hosted informational and sponsored classes for entrepreneurship training programs to help residents develop business management skills.
