Part III. Free Bikes 4 Kidz Maryland (fb4kmaryland.org) is a nonprofit organization geared toward helping all kids ride into a happier, healthier childhood by providing bikes to those most in need. The public donates gently used bikes, we organize hundreds of volunteers to clean and refurbish them, and then we give them away to kids in need. We're an independent affiliate of Minnesota-based Free Bikes 4 Kidz, which has since 2008 together with its affiliates given away over 70,000 bicycles using the services of over 35,000 volunteers donating over 156,000 service hours. FB4K Maryland was established in the summer of 2019, and startup fees and expenses were not insignificant. In order to reduce costs and avoid overloading volunteers, we conduct a single collect-refurbish-giveaway campaign each year. In 2019, we collected 512 bicycles in our first campaign and and refurbished and gave away 492 of them, 415 of them directly to under-served children, and the remainder to nonprofits and schools serving children.

Line 28. We conducted a bicycle refurbishing campaign in the fall, beginning with a collection day during which members of the public could donate disused bicycles to us for refurbishing. We enlisted the help of Howard County Government to use all of their 13 Fire Stations as collection points*, and collected 512 bicycles on collection day and during the weeks thereafter. We then refurbished almost all of those bikes (only 20 had to be scrapped, and only after being stripped of usable parts) in 4200 sq. ft. of space donated by Howard County government (estimated value of \$12000*), using over 175 volunteers collectively contributing over 1500 volunteer hours** spread over 120 work sessions between October 5 and December 10. Bikes received a final inspection by professional bike mechanics whose time was donated by Race Pace Bicycles, a local shop (estimated value of over \$5000*). We valued the bikes donated to us at current estimated retail prices using contemporaneous local "for sale" listings of similar bicycles, and listed the bikes given away by us at the same value ignoring the change in value attributable to refurbishing parts and labor**. We worked with local schools and nonprofits to identify underserved children in need of a bicycle, and gave a bicycle and new helmet to all 415 of the children thus identified. We also gave away 77 bikes and helmets to schools and nonprofits serving children or promoting children's bicycling, including the Howard County Public School System's Bicycle Education Program, a local Children's Home, a community bicycling program in Baltimore, and Bikes for the World. The financial reporting for this effort includes direct costs and indirect costs not associated with establishing the organization (e.g., insurance costs are included, but fees for incorporation, nonprofit filing, and initial tool acquisition are not). The dollar cost to us per bike given away was about \$22, plus about \$10 for a new helmet. This figure will go down as our operations scale up.
