

Since 1912, the Arizona YWCA Metropolitan Phoenix has been dedicated to eliminating racism, empowering women, and promoting peace, justice, freedom and dignity for all.

Senior Hunger and education programs - through the Meals on Wheels and the YWCA congregate meals program the YWCA provided 103,843 meals in 2015-2016. In 2014, 3 million households, 9%, with seniors age 65 or older experienced food insecurity. Locally, we know that 1 in 7 seniors in AZ live in poverty and AZ hunger rates are higher than national averages. 17.8% in AZ are food insecure compared to 15.9% nationally. YWCA coordinates services among 4 locations to provide nutritionally balanced hot meals at noon, educational opportunities, self improvement activities, health screenings, health fairs, activities and outings to engage and support clients.

4b (Code) (Expenses \$ 122223. including grants of \$) (Revenue \$)
Financial Education - YWCA Own It Financial Education Program is a comprehensive Money Management curriculum, provides strategies and tools. It empowers participants through a 4 week curriculum focused on fiscal management and education. The program is taught by volunteer financial professional who give of their time and expertise. These professionals hold certifications in their respective fields within financial management including banking, insurance, personal investing, credit and estate planning. This free program serves more than 150 individuals annually in collaboration with more than 20 nonprofits and organizations. 80% of participants report an increase in savings or reduced debt.

Advocacy - YWCA Womens Empowerment Series provides inspiring women presenters to educate and empower women on current issues and womens leadership. The YWCA holds 4 presentations each year with approximately 150 participants totalling more than 600 annually. The YWCA Young Womens Forum provides a dynamic setting where young female professional leaders in the community can connect with one another, share strategies and create support networks. The Young Womens Forum hosts 3 events annually with approx 50 people in attendance at each event, reaching 150 women annually. The YWCA Advocacy Committee is a collective voice that advocates for positive change for women, children and families throughout Arizona.
