Since 1912, the YWCA Metropolitan Phoenix has been dedicated to eliminating racism, empowering women and promoting peace, justice, freedom and dignity for all

Senior Hunger and other programs. The YWCA addresses senior hunger each day through the Meals on Wheels program and the YWCA congregate meals program providing 95,231 meals in 2017-2018. In 2014, 3.0 million (9%) households with seniors age 65 and older experienced food insecurity. Locally, we know that 1 in 7 seniors in Arizona live in poverty and Arizona's hunger rates are higher than national averages. 17.8% of Arizonans are food-insecure, compared to 15.9% nationally. YWCA coordinates services among four locations to provide nutritionally balanced hot meals at noon, educational opportunities, self-improvement activities, health screenings, health fairs, activities, and outings to engage and support clients. These visits often circumvent loneliness, isolation, and serve as mental health status checks. The YWCA also provides pet food for client animal companions through our We Feed Four Feet program. All clients are eligible to request food for their dog(s) and cat(s) and will receive the pet food from their driver. All YWCA program staff are trained and undergo background checks.

4b (Code _____) (Expenses \$ 187,350 including grants of \$ _____) (Revenue \$ _____)
Financial Education. YWCA Own It Financial Education Program is a comprehensive Money Management curriculum and tools and empowers participants through a four-week curriculum focused on fiscal management education. The program is taught by volunteer financial professionals who generously give of their time and expertise so that each class focuses on a different aspect of managing money. These professionals hold certifications in their respective fields within financial management including banking, insurance, personal investing and estate planning. This program serves more than 600 individuals annually, in collaboration with more than 35 non-profits and organizations, at no cost to the agencies. 80% of participants report an increase in savings or reduced personal debt six to nine months after completing the program. The program is growing to fill a need in the community. The program coordinator uses confidential income documentation forms to verify income eligibility and pre- and post-session surveys to measure client knowledge and before and after the course. Staff also contacts clients three and six months after the course to measure progress towards goals and provide additional support if needed.

Advocacy. YWCA Women's Empowerment Series provides exceptional professional women presenters to educate and empower women on current important issues and women leadership. The YWCA holds four presentations each year with approximately 150 participants totaling over 600 annually. The YWCA Young Women's Forum provides a dynamic setting where young female professional leaders in the community can connect with one another, share strategies and create support networks. The Young Women's Forum hosts 9 events annually with approximately 50 people in attendance at each event, teaching 150 women annually. The YWCA Advocacy Committee is a collective voice and that advocates for positive change for women, children and families throughout Arizona. The Advocacy Committee hosts an annual event in April, "Stand Against Racism" that engages over 20 organizations to work towards the elimination of racism. Stand Against Racism is a new program and reaches approximately 100 people annually. The Advocacy Committee also works to illuminate and end the gender pay gap.
