CCS helped 39 refugee families re-settle and adjust to their new homes. CCS also worked with 980 families in their efforts to unite with family members and immigrate to the United States through Casa Alitas. Help was provided to over 643 individuals seeking immigration consultation. CCS oversees two ministries: volunteers minister to approximately 1,000 incarcerated men, women, and youth each week, and in addition to developing parish-based ministries for elders, CCS' pastoral ministry chaplain and staff visit nearly 20 nursing homes each month. Finally, 2,563 individuals, children and adults received services to address domestic violence in the form of legal assistance, advocacy, and shelter.
