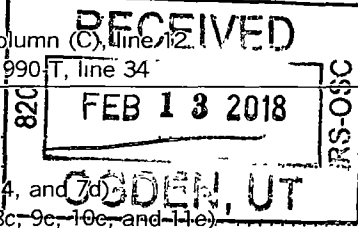

In 2014, the Sedona Chamber of Commerce & Tourism Bureau was awarded accreditation from the Destination Marketing Accreditation Program (DMAP). DMAP is an internationally recognized accreditation program developed by the Destination Marketing Association requiring organizations to demonstrate compliance composed of 58 mandatory standards including governance, finance, management, human resources, technology, visitor services, group services, sales, communications, membership, brand management, destination development, research/market intelligence, innovation and stakeholder relationships. DMAP is an independent international accrediting body and is globally recognized by the destination marketing industry. DMAP accreditation is considered one of the highest achievements in destination excellence.

The Sedona Chamber of Commerce (COC) is an integral part of tourism in Sedona and the surrounding area. Visitors provide more than ten million in local tax dollars which comprises more than 65% of the City of Sedona's budget and provides more that 10,000 area jobs.

The Sedona Chamber of Commerce's Visitor Center staff and volunteers serve as destination experts, greeting guests and offering insights into the area's amenities. The Visitor Center team serve more than 300,000 visitors per year on the phone, electronically and in-person. Volunteers donated more than 9,500 hours in fiscal year '16.

The COC has over 900 chamber members and boasts a 85% retention rate for its memberships.

New programs have provided the opportunity to increase Hometown Guide distribution to reach new residents and businesses. VisitSedona.com received over 4.2 million views with more than 1.3 million unique visitors. The online visitor guide received more than 3.1 million page views.
