Forgiveness of the loan is based on funds being used for certain expenses, including payroll costs and utilities, based on the Organizations application form. As of June 30, 2020, the Organization had incurred \$441,318 of eligible expenses, which has been recorded as a conditional contribution in the consolidating statement of activities for the year ended June 30, 2020. While there is no assurance that the Organizations obligation under the PPP loan will be forgiven, management believes that since the expenses incurred through June 30, 2020, have been spent in accordance with the criteria established for loan forgiveness and will apply for forgiveness within the time allowed under the program, all barriers for revenue recognition have been met. The outstanding loan payable balance at June 30, 2020 of \$65,667, will be recognized as a contribution during the year June 30, 2021, when the remaining related eligible expenses are incurred and criteria for forgiveness are met. In the event loan forgiveness is not granted, any unforgiven loan amounts plus interest at 1%, must be repaid within five years.</p>
