ADDITIONALLY, TGC CONTRACTED WITH TWO SCATTERED SITE APARTMENTS FOR HOUSING CONSUMERS. THESE UNITS PROVIDE ASSISTED AND INDEPENDENT LIVING QUARTERS FOR THE SERIOUSLY MENTALLY ILL (SMI) CONSUMERS. THROUGH THESE FACILITIES, TGC PROVIDED HOUSING FOR 41 SMI CONSUMERS IN FY 2017. TITLE 36 (T36) COURT ORDERED SERVICES ARE PROVIDED TO THE APPROVED OUTPATIENT TREATMENT PLAN FILED WITH THE COURT OF JURISDICTION.
