Board members are required to disclose all conflicts of interest, including conflicts of interest with respect to the CEO's compensation, at the time they join the Board and/or whenever such a conflict arises. When determining the CEO's compensation, the Board obtains and reviews appropriate data as to comparability. Appropriate data typically includes, but is not limited to, CEO compensation levels paid by comparable organizations in the Tucson & Phoenix Metropolitan Areas, and current compensation surveys compiled by independent entities including the Arizona State University Lodestar Centers tri-Annual Nonprofit Compensation & Benefits Report. The Board maintains written/electronic records that document their decisions regarding CEO compensation in the form of Board meeting minutes that capture the outcome of Executive Session discussions about this topic. The records specify the terms of the compensation and the date it was approved, the board members who were present during the debate of the approved compensation, the board members who voted on the approved transaction, the comparability data obtained and relied upon by the Board and how the data was obtained, and actions taken with respect to any Board member who had a conflict of interest related to the debate/vote. The specifics of the compensation decision are also sent by email from the Board Chair to the CEO and the Director of Finance, with written authorization by the Board Chair for the Director of Finance to adjust the CEO's compensation according to the details of the Board's decision.</p>
