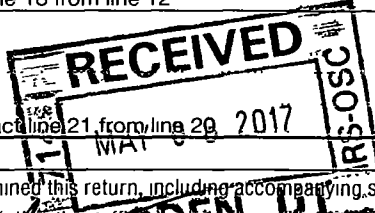

EMERGENCY CHILDREN'S SHELTER: CHILD CRISIS ARIZONA OPERATES THE ONLY LICENSED EMERGENCY SHELTER IN MARICOPA COUNTY, ARIZONA FOR CHILDREN AGES BIRTH TO 8-YEARS AND IS LICENSED TO SHELTER AS MANY AS 78 CHILDREN AT ANY GIVEN TIME. CHILDREN ARE PLACED INTO CARE WHEN REMOVED FROM THEIR FAMILIES FOR ABUSE, NEGLECT, OR OTHER FORMS OF MALTREATMENT BY THE DEPARTMENT OF CHILD SAFETY OR TRIBAL SOCIAL SERVICES. IN TIMES OF EXTREME DURESS, WHEN NO OTHER CARE OPTIONS ARE AVAILABLE, FAMILIES MAY VOLUNTARILY PLACE THEIR CHILDREN INTO CARE AT NO COST. TO BE ACCEPTED INTO THE PROGRAM, FAMILIES MUST DEMONSTRATE THEY ARE LIVING AT OR BELOW 200% OF THE FEDERAL POVERTY LEVEL AND HAVE A HIGH SCORE ON A RISK ASSESSMENT.
