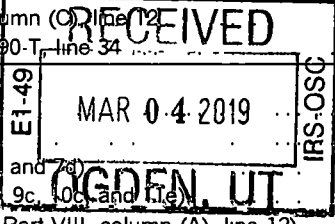

THE PURPOSE OF CFC'S FOSTER CARE MINISTRY IS TO PROVIDE SAFE, CHRIST-CENTERED HOME TO AT-RISK, WOUNDED CHILDREN.
