Jewish Family & Children's Services (JFCS) - Jewish Family & Children's Services was awarded \$20,020 to renovate and refurbish a play therapy room which is used to provide play therapy services to over 150 children per year who have experienced psychological trauma. The room in the Jewish Family & Children's Services Tucson facility will be designed with equipment and toys to help the children heal and develop in healthy ways. Boys to Men - Boys to Men was awarded \$10,100 to support a campaign to recruit and train men to help 200 at-risk middle and high school aged boys at weekly group mentorship meetings. The program will expand outside Tucson Unified School District into Sunnyside and Flowing Wells school districts and the Pima County Juvenile Detention Center. \$1,928 of expenses related to the administration of grants. \$10,000 of prior periods additional beneficiary expense.
