Emergency Assistance Since 1985, ICS has provided financial assistance, short-term case management, and other support for individuals or families in emergency situations. The goal is to provide for acute basic needs that help clients in distress get back on their feet and take steps toward stability and independence. The types of assistance include rent and shelter to prevent homelessness, utilities, food and gas vouchers, and back-to-work expenses such as permits, ID's and clothing vouchers. During 2017-18, ICS served 2,721 households providing \$1,015,431 in financial assistance (4% increase). ICS partners with the Community Food Bank of Southern Arizona to distribute emergency food boxes each month to low-income seniors, individuals and families in need. During 2017-18, ICS distributed \$2.9 million worth of food (down 7% from last year due to increase self-sufficiency).

Community Engagement Since 1985, Interfaith Community Services (ICS) has partnered with many agencies and diverse faith communities in order to respond to low-income, senior and disabled individuals in the greater Tucson area. These partners are also essential points of contact for announcing volunteer opportunities since over 970 volunteers are integral to all programs. Volunteers are the community connection point for ICS, and the majority of the agency's direct services to clients are carried out by volunteers. ICS volunteers provided more than 67,425 hours of volunteer time during the year.

Senior & Caregiving Services Since 1985, Interfaith Community Services (ICS) has provided services which help seniors and disabled individuals to live independently in their own homes, without the need for institutional care. Volunteers provide services such as fresh nutritious meals, transportation for medical appointments and shopping, friendly phoning, friendly visiting, small home repairs, and business help. During 2017-18, ICS provided services to 2,096 seniors and disabled individuals (19% increase). The Mobile Meals program provides delivery of fresh nutritious meals each weekday to elderly, physically challenged or convalescing adults who are unable to cook for themselves. Mobile Meals are provided on a sliding-scale-fee basis based on ability to pay. More than 60% of Mobile Meals recipients receive fully or partially subsidized meals. ICS served 26,946 meals during the year.
