Transformative Mentoring - The organization serves youth whose needs go far beyond simple assistance, companionship, confidence building and minor academic or career guidance due to environmental circumstances, poverty, gangs, substance abuse, violence, etc, which have resulted in problematic and disruptive attitudes and behaviors. As a result, the organization employs a kind of mentoring that requires very different considerations such as time commitment, mentor skill sets and training needs, mentor recruitment and match support strategies. The organization also works with youth to provide college and career readiness support as early as age 9. More than 550 youth were served last year. 120 life skill development workshops were held last year that build essential skills for college and career success. 40 parenting/caregiver workshops were held to support stability for youth.
