Programs are free but are incentivized to clients by providing client cash or points for attending classes that can be used in our womens resource room for material resources and utility assistance. Classes are a mix of life skills and faith based topics such as parenting, English as a second language, anger management, grief and loss, health and nutrition, healthy relationships, crafts, parent-child bonding, and job readiness. Our mentoring program provides trained mentors and staff to meet with clients to discuss crisis pregnancy, domestic abuse, unemployment, homelessness, prostitution/rape, family conflict, substance abuse recovery, and other life challenges. Other programs include our childrens programs and a new program for birth moms whose children are in foster care or at risk of foster are focused on early intervention, creating health home environments, and support for moms working on re-unification.
