THE ORGANIZATION PROVIDED DECENT, SAFE, SANITARY AND AFFORDABLE HOUSING TO 46 RESIDENTS. 56% BETWEEN AGES 62-80, 44% BETWEEN AGES 81-95 AND 0% 96+. ARIZONA RETIREMENT HOMES-II EMPLOYS A SERVICE COORDINATOR WHO ASSISTED RESIDENTS WITH OBTAINING A VARIETY OF SOCIAL SERVICES. THESE SERVICES INCLUDED ADVOCACY, BENEFITS/ENTITLEMENTS/INSURANCE, CRISIS INTERVENTION/SUPPORT COUNSELING, GENERAL INFO/REFERRAL, HEALTHCARE SERVICES, HOME MANAGEMENT, FOOD/MEALS, RESIDENT COUNCILS AND TRANSPORTATION. THE SERVICE COORDINATOR ALSO ARRANGED FOR RESIDENT IN-SERVICES AND CLASSES ON TOPICS SUCH AS (CONTINUED ON SCHEDULE O) COPING WITH GRIEF AND LOSS (HOSPICE OF THE VALLEY), AHCCCS, MEDICARE Q & A, AARP RESOURCES FOR SENIORS, HEALTH FAIR/SCREENING, FIRE SAFETY, CHRONIC DISEASE PREVENTION, RX MATTERS AND CPR. THE SERVICE COORDINATOR COORDINATED OTHER ON-SITE PROGRAMS FOR BROWN BAG, WASTE NOT, FOOD PLUS, ST MARY'S FOOD BANK, FLU SHOTS, WALKING CLUB/FITNESS/WEELLNESS EDUCATION, MATTER OF BALANCE, TAI CHI AND VARIOUS TROLLEY TRIPS.
