THE ORGANIZATION PROVIDED HOUSING AND SUPPORTIVE SERVICES TO ELDERLY AND PERSONS WITH DISABILITIES THROUGH THE OPERATION OF A 41-UNIT RETIREMENT HOME COMPLEX IN PHOENIX, ARIZONA. THE ORGANIZATION SERVED 40 RESIDENTS. 2% ARE BETWEEN AGES 18-61 (DEPENDENT/GRANDCHILD), 80% BETWEEN THE AGES 62-80, 16% BETWEEN AGES 81-95 AND 2% OVER 96. APPROXIMATELY 23% OF THE RESIDENTS ARE IDENTIFIED AS AT-RISK ELDERLY, AND 45% ARE IDENTIFIED AS FRAIL ELDERLY. ST MARY'S MANOR EMPLOYS A SERVICE COORDINATOR WHO ASSISTS RESIDENTS IN OBTAINING NEEDED SUPPORTIVE SERVICES FROM COMMUNITY AGENCIES. THIS COORDINATOR IS A VALUABLE RESOURCE PERSON WHO ASSISTED RESIDENTS WITH SERVICES SUCH AS ASSESSMENTS, CASE MANAGEMENT, CONFLICT RESOLUTION, BENEFITS/ENTITLEMENTS, HOME MANAGEMENT (CONTINUED IN SCHEDULE O), HEALTHCARE SERVICES, ISOLATION INTERVENTION, MEALS, TRANSLATION/INTERPRETATION AND TRANSPORTATION. ALONG WITH PROVIDING RESOURCES, THE SERVICE COORDINATOR ARRANGED THE FOLLOWING EDUCATIONAL AND WELLNESS IN-SERVICES FOR THE RESIDENTS: QUALITY HOSPICE, MEDICARE, MEDICARE Q & A, ADVANCED DIRECTIVES AND FOSTER GRANDPARENTS. OTHER WEEKLY OR MONTHLY ON-GOING PROGRAMS AND ACTIVITIES INCLUDED TAI CHI, SIT AND BE FIT (CHAIR EXERCISES), BLOOD PRESSURE CLINICS, NUTRITION CLASS AND GAMES WITH STUDENTS. RESIDENTS ALSO ENJOYED RESIDENT-DIRECTED ACTIVITIES AND SOCIAL EVENTS SUCH AS BARBECUES, PANCAKE BREAKFASTS, BIRTHDAY PARTIES, TEA PARTIES, BIBLE STUDIES, RESIDENT COUNCIL MEETINGS, ACTIVITY COMMITTEE MEETINGS, DOMINOES AND BINGO.
