



MENTORS USE YOUTH DEVELOPMENT TECHNIQUES TO BUILD RELATIONSHIPS WITH THEIR GROUP, HELPING CHILDREN TO INCREASE THEIR TRUST IN ADULTS AND FORM STRONGER BONDS WITH THEIR PEERS. 46 PROGRAMS WERE DELIVERED, SERVING 967 CHILDREN USING 87 MENTORS WORKING 2,358 HOURS, VALUED AT \$56,777.
