FREE ARTS FOR ABUSED CHILDREN OF ARIZONA (FREE ARTS) IS A NONPROFIT ORGANIZATION THAT TRANSFORMS CHILDREN'S TRAUMA TO RESILIENCE THROUGH THE ARTS. OVER THE PAST TWENTY-FIVE YEARS, FREE ARTS HAS PROUDLY SERVED MORE THAN 125,000 CHILDREN IN MARICOPA COUNTY. FREE ARTS HAS 19 STAFF MEMBERS AND 864 VOLUNTEER MENTORS WHO SERVE NEARLY 8,000 CHILDREN EACH YEAR. FREE ARTS PARTNERS WITH 40 INDIVIDUAL SOCIAL SERVICE AGENCIES AT 100+ SITES TO PROVIDE A UNIQUE COMBINATION OF ARTS, A TRAUMA INFORMED CURRICULUM, AND MENTORING, TO CHILDREN WHO ARE IN OUT-OF-HOME CARE. FREE ARTS USES THE ARTS TO BUILD RESILIENCE IN CHILDREN WHO HAVE EXPERIENCED THE TRAUMA OF ABUSE, NEGLIGENCE, OR HOMELESSNESS.
