Under ASC 740, the aforementioned entities recognizes deferred tax assets and liabilities for the expected future tax consequences of events that are recognized differently in its financial statements as compared with its income tax return. Under this method, deferred tax liabilities and assets are determined based on the difference between the financial statement carrying amounts and tax basis of assets and liabilities using enacted tax rates. When necessary, deferred tax assets are reduced by a valuation allowance when, in the opinion of management, it is more likely than not that some portion or all of the deferred tax assets will not be realized. VILLASINC, VILLASII, RPA, MPI, WPI, SPAI and AHI serve as the general partner to low income housing tax credit projects and have limited other activity. Consequently, no tax provision or deferred tax assets or liabilities were recorded in the consolidated financial statements for the aforementioned entities as of and for the years ended June 30, 2020 and 2019, respectively. Stonecorner has federal net operating loss carryforwards ("NOL's") available of approximately \$277,000 as of June 30, 2020 to offset future taxable income. A deferred tax asset of \$69,062 has been recorded as a result of these NOL's. Although realization is not assured, Stonecorner believes it is more likely than not that all deferred tax assets will be realized, so no valuation allowance has been recorded. Management has considered its tax positions and believes that all of the positions taken in its federal and state tax returns are more likely than not to be sustained upon examination. The Organization's returns are subject to examination by federal and state taxing authorities, generally for three years and four years, respectively, after they are filed. The Organization's policy is to record any interest and penalties related to unrecognized tax benefits in general and operating expenses and accounts payable in the accompanying consolidated financial statements. During the years ended June 30, 2020 and 2019, the Organization did not recognize any interest or penalties.</p>
