THIS ORGANIZATION PROVIDED HOUSING AND SUPPORTIVE SERVICES TO ELDERLY AND PERSONS WITH DISABILITIES THROUGH THE OPERATION OF A 24-UNIT RETIREMENT HOME COMPLEX IN PHOENIX, ARIZONA. THE ORGANIZATION SERVED 24 RESIDENTS: 4% UNDER THE AGE OF 62 (NON-ELDERLY/DISABLED), 83% BETWEEN THE AGES 62-80, 13% BETWEEN 81-95 AND 0% 96 AND OVER. OF THIS POPULATION 5% WERE CLASSIFIED AS AT-RISK ELDERLY. THE RESIDENTS OF FILLMORE COURTYARD APARTMENTS ARE PROVIDED ASSISTANCE WHEN THEY NEED NUTRITIONAL BENEFITS OF FOOD BOX PROGRAMS THROUGH THE CHURCH OF FILLMORE (AN ARIZONA NON-PROFIT CORPORATION AND THE SINGLE MEMBER OF FILLMORE HOUSING CORPORATION, OWNER OF THIS PROJECT). THE CHURCH IS LOCATED ADJACENT TO THE APARTMENTS. IN ADDITION, THE MANAGER OF THE PROPERTY, THROUGH THE USE OF A COMMUNITY (CONTINUED ON SCHEDULE O) INFORMATION AND REFERRAL DIRECTORY AND OTHER RESOURCES, IS ABLE TO DIRECT RESIDENTS TO VARIOUS AGENCIES THAT DEAL WITH ALMOST EVERY ISSUE FACING LOW-INCOME AND ELDERLY CITIZENS.








