2020 program accomplishments include the filing of litigation to require the City of Phoenix to comply with federal law in administering its emergency rental assistance program. A favorable judgment was entered and thousands of previously ineligible persons were able to apply for assistance during the COVID-19 pandemic. The Institute published a study of court and attorney practices in eviction cases. The study was based on a year and a half of research. The Institute filed an administrative complaint against the City of Glendale for not following federal law in administering its subsidized housing programs. After the complaint was filed, the City of Glendale worked with the Institute to make the necessary changes. It is now a model program. The Institute submitted objections to AHCCCS and the federal government concerning the state waiver requests to the Arizona Medicaid program. The Institute specifically objected to the implementation of work related requirements. In 2021 the Biden administration revoked the Arizona Medicaid work requirements.
