1 Briefly describe the organization's mission or most significant activities
The mission of Old Pueblo Community Services is to provide solutions to homelessness in the effort to end and prevent chronic homelessness in Tucson. In 2015, OPCS adopted the Housing First model across the variety of housing solutions we offer including shelter, transitional housing, and permanent supportive housing. These solutions offer immediate options for persons most vulnerable, guided by the notion that there should be no barriers to housing. Substance abuse counseling, case management and employment support are then offered to ensure long-term success as persons integrate into the community, not as a condition to housing. An example of the success of this model is Isabel House, our first recovery community to use this approach. In its first year, 87% of Isabel residents transitioned into their own permanent home. Even those with the highest needs can have incredible outcomes if we follow proven practices.

Housing Development/Home Ownership - The Housing Department assisted 166 families/individuals with homebuyer education, down payment assistance, & HUD certified housing counseling Our staff counseled 74 families/individuals facing foreclosure, & 155 homeowners interested in reverse mortgages We renovated 12 owner-occupied homes In addition, we assisted two first-time home buyers in buying a new home through a Community Renewal grant from the City of Tucson

Reentry Communities - Transitional Housing and/or Counseling for both veteran and non-veteran clients In 2015, we served 673 clients, of which 458 were male and 215 were female We provided housing, case management, recovery support services and/or counseling Of these clients, 631 (94%) had some type of disability and 238 of them were considered chronically homeless We also served 43 households with children in our permanent supportive housing program We began the next Inside Out Recovery Program in the fall of 2014 and are continuing to identify clients from the jails to provide intensive outpatient therapy after release The One Step at a Time grant also began in early 2015 These clients come from our Arizona prisons This program includes intensive therapy for 60-90 days post release, with transitional housing and case management We work with the Department of Corrections and begin this program while the clients are still incarcerated Veteran Communities - We continue to have 8 veteran programs here at OPCS In 2015, we served 524 veterans of which 464 were male and 59 were female and one transgender Of these clients, 455 (90%) had some type of disability and 123 of them were considered chronically homeless One of our current veteran contracts was awarded an additional 16 beds to provide transitional housing, case management and substance abuse counseling to veterans who may come into this program "less than sober " We are continuing to move towards permanent housing for the chronically homeless and those who face homelessness We are working closely with the Tucson Mayor, Jonathan Rothschild, to assess and provide housing and services to our homeless veterans Our outreach program has grown tremendously and is a model program for other cities around the country
