THE CLINIC PROVIDED PRIMARY AND ACUTE CARE TO PATIENTS WITHOUT MEDICAL INSURANCE. IN 2017, THE CLINIC HAD APPROXIMATELY 9,600 PATIENT VISITS AT AN AVERAGE OFFICE VISIT CHARGE OF \$30 PER VISIT. IN ADDITION, MANAGEMENT HAS VALUED THE APPROXIMATELY 7,010 HOURS OF VOLUNTEER SERVICE HOURS PERFORMED BY SKILLED MEDICAL AND DENTAL PROFESSIONALS AT \$274,575. MANAGEMENT HAS ALSO VALUED THE DONATED SERVICES OF OTHER NON-SKILLED VOLUNTEERS WHO HAVE DONATED THEIR TIME AT APPROXIMATELY \$38,468.
