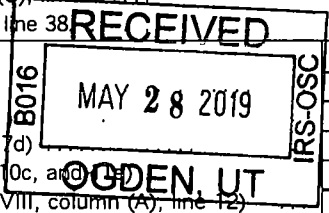

IN ADDITION, MANAGEMENT HAS VALUED THE APPROXIMATELY 8,695 HOURS OF VOLUNTEER SERVICE HOURS PERFORMED BY SKILLED MEDICAL AND DENTAL PROFESSIONALS AT \$321,133.
